PAO Standard Office Procedures in Extending Legal Assistance to CICL Under R.A. 9344 and Other Related Laws

NOW THEREFORE, in view of the above premises, the Council resolves, and it is hereby resolved, to formally adopt the PAO Standard Office Procedures in Extending Legal Assistance to CICL Under R.A. 9344 and Other Related Laws.
