Creation of the JJWC Bids and Awards Committee

WHEREAS, Republic Act No.9344, otherwise known as the "Juvenile Justice and Welfare Act of 2006"; created the Juvenile Justice and Welfare Council (JJWC) attached under the administrative supervision of the Department of Justice;

WHEREAS, the Council needs a decent office, various equipment and numerous supplies to carry out its mandate under the law;

WHEREAS, JJWC procurement needs immediate action since it is in the process of organization and implementation of the law;

WHEREAS, the Department of Justice Bids and Awards Committee (BAC) has also to attend to the Department of Justice requisitions and procurement resulting to the delay of the procurement needs of the JJWC;


WHEREAS, Section 11, RA No. 9184 authorizes the creation of a separate BAC as the head of the processing entity deems necessary;

WHEREAS, the BAC should be Chaired by a 3rd ranking permanent official plus three (3) regular members and two (2) provisional members;


NOW THEREFORE, the Council resolves, as it is hereby resolved, to create a separate Bids and Awards Committee of the JJWC composed of the following:
