COUNCIL RESOLUTION NO. 2011- 45

Re: Designation of the Two Council Members from Non-government Organizations

WHEREAS, Republic Act 9344, otherwise known as the “Juvenile Justice and Welfare Act of 2006” created the Juvenile Justice and Welfare Council (JJWC), prescribed its mandates, composition, and term of office of the two non-government organization representatives;

WHEREAS, since the Council’s inception in 2006, non-government organizations are being represented by ERDA and Consuelo Foundations;

WHEREAS, the Council through Resolution No. 28 dated April 3, 2009 adopted the criteria for the selection of the future non-government organizations representatives to the Council;

WHEREAS, in compliance with the provision of the law (Section 8) and agreement of the Council to already appoint new members from the non-government organizations, the DSWD and DOJ, the two agencies mandated by the law to designate representatives have chosen PLAN INTERNATIONAL and Structural Alternative Legal Assistance for Grassroots (SALAG) respectively;

WHEREFORE, in view of the foregoing considerations, the Council resolves, as it is hereby resolved to adopt the selection of SALAG and PLAN International as the two new members of the Council representing non-government organizations. Assumption of membership shall commence on the date of the adoption of this resolution and each representative shall have a term of two years as prescribed by the law;

RESOLVED FURTHER, that the Council expresses its wholeheartedly gratitude and appreciation to the unequivocal, unparalleled and excellent participation and contribution of Consuelo Foundation and ERDA Foundation in the Council’s work for the past five years. As members their presence and involvement are immeasurable to which the Council will always be grateful.
