COUNCIL RESOLUTION NO. 22
Series of 2008
JJWC Secretariat Mid-Year Bonus

WHEREAS, the Juvenile Justice and Welfare Council hired office personnel on a contractual basis to man the secretariat office pursuant to Section 8 of Republic Act No. 9344, otherwise known as the "Juvenile Justice and Welfare Act of 2006",

WHEREAS, the Juvenile Justice and Welfare Council has sufficient funds to pay for the salaries and other benefits of its personnel;

WHEREAS, Section 42 of the General Appropriations Act of 2007, provides that: "A year-end bonus equivalent to one (1) month basic salary and additional cash gift shall be granted to all national government officials and employees, whether under regular, temporary, casual or contractual status, on full-time or part-time basis, who have rendered at least a total of four (4) months of service";

WHEREAS, 2.1 of Budget Circular No. 2205, dated 28 October 2005 (Updated Rules and Regulations on the Grant of the Year-end Bonus and Cash Gift to Government Personnel for FY 2005 and years thereafter), allows the grant of Mid-Year Bonus and cash gift to government personnel;

WHEREAS, last December 2007, the Staff of the Secretariat have been granted a year-end bonus and cash gift amounting to Five Thousand Pesos;

WHEREAS, the staff of the different units and offices of the Department of Justice have already received one half (½) of their bonuses as early as May of this year;

WHEREFORE, in view of the foregoing considerations, the Council resolves, as it is hereby resolved, to recommend to grant the personnel of the JJWC Secretariat a Mid-Year bonus equivalent to half month of their respective salaries, subject to the usual accounting and auditing rules and guidelines.
