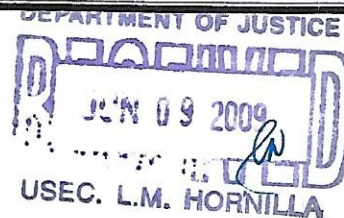

COUNCIL RESOLUTION NO. 29
Series of 2009

JJWC Secretariat Bonus and Additional Cash Gift at Mid-Year and Year-End

WHEREAS, the Juvenile Justice and Welfare Council hired office personnel on a contractual basis to man the secretariat office pursuant to Section 8 of Republic Act No. 9344, otherwise known as the "Juvenile Justice and Welfare Act of 2006;"

WHEREAS, the Juvenile Justice and Welfare Council has sufficient funds to pay for the salaries and other benefits of its personnel;


WHEREAS, Section 42 of the General Appropriations Act of 2007, provides that: "A year-end bonus equivalent to one (1) month basic salary and additional cash gift shall be granted to all national government officials and employees, whether under regular, temporary, casual or **contractual status**, on full-time or part-time basis, who have rendered at least a total of four (4) months of service;"


WHEREAS, 2.1 of Budget Circular No. 2205, dated October 28, 2005 (Updated Rules and Regulations on the Grant of the Year-end Bonus and Cash Gift to Government Personnel for FY 2005 and years thereafter), allows the grant of bonus and cash gift to government personnel;


WHEREAS, the staff of the JJWC Secretariat was granted a bonus and cash gifts given out at mid-year (August 2008) and year-end (January 2009);


WHEREFORE, in view of the foregoing considerations, the Council resolves, as it is hereby resolved, to recommend to grant the staff of the JJWC Secretariat its due bonus and additional cash gift that shall be divided into two (2) and be given out at mid-year and year-end, subject to the usual accounting and auditing rules and guidelines


