COUNCIL RESOLUTION NO. 33

Series of 2009

Approval of the Allocation of Funds in Payment for the Remaining Balance for the Purchase of the JJWC Office

WHEREAS, in view of the need for the office to function properly and effectively, the members of the Council agreed to purchase a permanent and adequate office for the Juvenile Justice and Welfare Council;

WHEREAS, the Council resolved in Council Resolution No. 26 (series of 2009) to allocate an amount—with a range from Ten to Fifteen Million Pesos out of the PhP 50 Million initial fund of the Juvenile Justice and Welfare Council (JJWC) as reflected in the **General Appropriations Act of 2008** under the Department of Justice—for the purchase of one (1) office that will serve as the JJWC office, subject to the usual accounting and auditing rules and procedure;

WHEREAS, the Council resolved in Council Resolution No. 30 dated May 29, 2009, that the amount of Five Million Pesos (PhP 5,000,000.00) released from the Philippine Charity Sweepstakes Office (PCSO) be allotted as the first tranche of the payment for the office;

WHEREAS, the remaining balance for the payment for the office in the amount of PhP 9,135,500.00, as per the Contract to Sell, shall be paid "on or before two (2) months from the date of payment of the deposit on the condition that the


Sellers execute a Deed of Absolute Sale over the Subject Property in favor of the Buyer."




