Adoption by the Juvenile Justice and Welfare Council of *A Child that Cries for Another Chance (A Training Module for BCPC on the Juvenile Justice and Welfare Act (RA 9344))*

WHEREAS, the Juvenile Justice and Welfare Act of 2006 (Republic Act 9344) prescribes the roles and functions of law enforcement officers in the administration of juvenile justice;

WHEREAS, the Implementing Rules and Regulations of R.A. 9344 mandates the Juvenile Justice and Welfare Council to formulate and recommend guidelines and policies pursuant to the implementation of the law;

WHEREAS, the Juvenile Justice and Welfare Council, in its Council Resolution No. 20, dated April 23, 2009, approved and adopted the *DILG General Guidelines in Handling CICL by the BCPC (Per RA 9344)*;

WHEREAS, the *A Child that Cries for Another Chance (A Training Module for BCPC on the Juvenile Justice and Welfare Act (RA 9344))* was submitted to the JJWC for approval;


