## COUNCIL RESOLUTION NO. 9

Series of 2007

**WHEREAS**, during the 9<sup>th</sup> regular meeting of the Juvenile Justice and Welfare Council (JJWC) held on 24 April 2007, one of the topics discussed was the establishment of a permanent office for the Juvenile Justice and Welfare Council, pursuant to provisions of R.A. 9344, otherwise known as the "Juvenile Justice and Welfare Act of 2006",


**WHEREAS**, the JJWC office is at present temporarily occupying a small space in the Parole and Probation Administration Office, located at DOJ Agencies Building, NIA Road, corner East Avenue, Diliman, Quezon City, which can only accommodate at the most three (3) personnel without any space for its records, equipment and office supplies;


**WHEREAS**, in view of the need for the office to function properly and effectively, the members of the Council agreed to purchase three (3) condominium units consisting of a total of 150 square meters, more or less, as a permanent office of the Juvenile Justice and Welfare Council;


**WHEREAS**, the Council agreed to purchase said condominium units out of the FIFTY MILLION PESOS (50,000,000.00) initial fund provided for by the law (Section 6, R.A. 9344) principally for the purpose of setting up the JJWC office;


**NOW THEREFORE**, the Council resolves, as it is hereby resolved, to allocate the amount of Six Million and Five Hundred Thousand Pesos out of the P50 Million initial fund for the purchase of three (3) condominium units which shall serve as the JJWC office, subject to the usual accounting and auditing rules and procedure.




