**RESOLUTION NO. 1, s. 2019**

**Resolution Granting Honorarium to RJJWC Member Agencies' Designated Staff Attending Regular Meetings of the RJJWC BARM**

*WHEREAS*, Republic Act 9344, as amended, provides the legal basis for the creation of the Juvenile Justice and Welfare Council (JJWC), the inter-agency body mandated to formulate and develop policy, coordinate and monitor the implementation of the Juvenile Justice and Welfare Act (JJWA),

*WHEREAS*, Republic Act 9344, as amended by Republic Act 10630, mandated the Juvenile Justice and Welfare Council (JJWC) to formulate policies and develop programs on Juvenile Justice and welfare and to continue to review, formulate and adopt plans, policies, rules and regulations, to ensure the effective and efficient implementation of the Juvenile Justice and Welfare Act;

*WHEREAS*, the Regional Economic and Development Planning Board (REDPB) through Regional Social Development Committee adopted resolution number 1 of 2016 thereby creating the Regional Sub-Committee on Juvenile Justice and Welfare and expansion of additional member.

*WHEREAS*, *Rule 12.b. of RA 9344 Designation of Representatives to the RJJWC provides:*

The concerned office heads shall designate their representatives to the RJJWC. The heads of the concerned offices shall name a permanent and an alternate representative, with ranks of at least Regional Director and Assistant Regional Director, respectively, or equivalent positions.

*WHEREAS*, *Rule 12.d. RA 9344 as amended by RA 10630 as amended by RA 10630 Emoluments provides:*

The designated representatives shall receive emoluments, as may be determined by the Council, in accordance with existing laws, Civil Service rules and applicable regulations on government budgeting and accounting.

**WHEREAS**, the Juvenile Justice and Welfare Council adopted resolution as of 2017 Granting Honorarium to Juvenile Justice and Welfare Council and Regional Juvenile Justice and Welfare Committees amounting to Php 2,000.00 per attendance to Regular and Special Meetings;

**WHEREAS**, RJJWC BARMM discussed the matter of honorarium for designated staff of member agencies attending regular and special meetings of the Committee;

**WHEREAS**, it is observed that most of the members agencies' designated staff who attend the committee's regular and special meetings are not occupying positions equivalent to Regional Director and Assistant Regional Director for the following reasons:

- a) Most ministries in the region only have skeletal forces;
- b) Hectic schedule of those in higher level positions (Director/Assistant Directors);
- c) Technical people are more grounded have freer time to gather necessary information for policy development

**NOW THEREFORE, BE IT RESOLVED** as it is hereby RESOLVED that designated staff of member agencies who attend the regular and special meeting of the Committee shall be entitled to the honorarium in the amount of Two Thousand Pesos (Php 2,000) per meeting.

**RESOLVED FURTHER**, that for agencies that send more than one representative to the Committee meetings, the amount of Php 2,000 shall be shared among said representatives.


**RESOLVED FINALLY**, that this Resolution be submitted for JJWC consideration and approval.




