“EXCEPT FROM THE HIGHLIGHTS OF THE MEETING OF THE REGIONAL JUVENILE JUSTICE AND WELFARE COMMITTEE ARMM THE INSTALLATION OF RJJWC ARMM HELPLINE “HOTLINE” FOR THE CASES OF CAR AND CICL

WHEREAS, RA 9344, as amended, provides the legal basis for the creation of the Juvenile Justice and Welfare Council (JJWC), the inter-agency body mandated to formulate and develop policy, coordinate and monitor the implementation of the Juvenile Justice and Welfare Act (JJWA),.


WHEREAS The law mandated the RJJWC to establish policy for coordination and implementation of the juvenile intervention programs and activities by national government agencies and other activities within the region;

WHEREAS, RJJWC members collect relevant regional information and conduct continuing research and support evaluations and studies on all matters relating to juvenile justice and welfare within the region


WHEREAS, RJJWC ARMM convened regular meeting to discuss matters to immediately respond to CAR and CICL issues, the committee meeting held last June 8, 2018 at which a quorum was present and agreed by the members;

WHEREFORE, Be it hereby resolved by the Regional Juvenile Justice and Welfare Committee ARMM through the RJJWC secretariat shall establish CICL HELPLINE “HOTLINE” to immediately respond to cases of CAR and CICL within the region.






