



**NOTICE FOR 5TH NEGOTIATED PROCUREMENT OF ONE (1)
UNIT OF ASIAN UTILITY VEHICLE (AUV)/CROSSOVER
UTILITY VEHICLE (CUV) FOR THE JJWC NATIONAL

1. The *Juvenile Justice and Welfare Council*, through the *PCSO Fund 2021*, intends to apply the sum of *One Million Two Hundred Thousand Pesos (Php 1,200,000.00)* being the ABC to payments under the contract for **5th Procurement of One (1) Unit of Asian Utility Vehicle (AUV)/Crossover Utility Vehicle (CUV) for the JJWC National Secretariat.**
2. The *Juvenile Justice and Welfare Council* now invites technically, financially, and legally capable supplier for the aforementioned procurement.
3. The procurement procedure for this requirement is Negotiated Procurement pursuant to Section 53.1 – Two Failed Biddings of the 2016 Revised Implementing Rules and Regulations (IRR) of the republic Act (R.A.) No. 9184, otherwise known as the “Government Procurement Reform Act,” including Annex H thereof.

6. Interested suppliers shall submit the following documents in sealed envelopes, labeled as “Negotiated Document”, with the title project name of the interested supplier, address of the interested supplier, and contact details of the interested supplier, addressed to the undersigned.
7. Technical and Eligibility Requirements:
 - a. PhilGEPS Platinum Certificate
 - b. Updated Mayor’s Permit
 - c. Latest Income Tax Return
 - d. Single Largest Completed Contract which is similar in nature within three (3) years from the date of submission of Sealed Quotations and whose value must be at least fifty percent (50%) of the Approved Budget for the Contract.
 - e. Accomplished RFQ Form and Annex A signed by the BAC Chairperson with supported evidence (manufacturer’s un-amended sales literature, unconditional statements of specification and compliance issued by the manufacturer, samples, independent test data etc., as appropriate) pertaining to the details of the product being offered.
 - f. Omnibus Sworn Statement (with Secretary’s Certificate for Corporation)
8. Within ten (10) calendar days from receipt of the Notice of Award by the winning supplier from the Procuring Entity but in no case later than prior to the signing of the Contract by both parties, the successful supplier shall furnish the performance security in any of the following forms:

1. Cash or cashier’s/manager’s check issued by a Universal or Commercial Bank.	Five percent (5%) of the total contract price
2. Bank draft/guarantee or irrevocable letter of credit issued by a Universal or Commercial	

Bank: Provided, however, That it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank.	
1. In the form of Surety Bond	Thirty percent (30%) of the total contract price

9. The Inspection Team and the end-user will conduct a two-stage inspection of the vehicle (inspection before and after the delivery of the vehicle)
10. Upon delivery of the Goods to the Project Site, the Supplier shall notify the Procuring Entity and present the following documents:
 - a. Original copy of the manual booklet
 - b. Original copy of the delivery receipt
 - c. Original copy of the billing statement/Sales Invoice
 - d. Conduction Number/Sticker
11. Processing of the payment shall only commence after the completion of the LTO Registration and submission of LTO Registration documents.
12. A warranty security shall be required from the successful supplier in the amount of one percent (1%) of the total contract effective upon the duration of the warranty period in the form of either retention money or special bank guarantee.
13. The *Juvenile Justice and Welfare Council* reserves the right to reject any and all quotations, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
