SUPPLEMENTAL BULLETIN NO. 1 dated 26 August 2021

This Supplemental/Bid Bulletin No. 1 is issued to clarify and correct items and certain provisions in the Bidding Documents for the Layouting, Printing and Delivery of Additional Copies of Prosecutor's Manual in Handling Cases of Children in Conflict with the Law, as follows:

I. AMENDMENT OF THE SCHEDULE OF REQUIREMENTS AND TECHNICAL SPECIFICATIONS

For the correction of the clerical error in the Section VI Schedule of Requirements and in relation with the request of the end-user during the pre-bid conference to shorten the layouting time of the project, the Section VI Schedule of Requirements and VII Technical Specification of the Bidding Documents are hereby amended as follows:

This amendment shall apply to all the provisions in the bidding documents regarding the schedule of delivery.

In relation to the inquiry of an interested bidder during the pre-bid conference about the availability of the file for the printing project, the Bids and Awards Committee would like to clarify that the file for the printing will be provided by the end-user and the layouting will be for the printing of the mock sample.
