SUPPLEMENTAL BULLETIN NO. 1 dated 21 June 2021

This Supplemental Bulletin is being issued to amend and/or clarify certain provisions in the Notice for Negotiated Procurement for the Procurement of One (1) Unit of Asian Utility Vehicle/Crossover Utility Vehicle (CUV) for the JJWC National Secretariat under RFQ No. 21-024, as follows:

I. THE REQUIREMENT OF PERFORMANCE SECURITY AND WARRANTY SECURITY

The Bids and Awards Committee wishes to clarify to the interested suppliers that the performance security and warranty security will be required to the winning supplier after the award of contract with the following details.

Performance Security <ul style="list-style-type: none">• Cash or Cashier's/ Manager's Check issued by a Universal or Commercial Bank .	<u>5% of the Contract Price</u>
Warranty Security <ul style="list-style-type: none">• Either through retention money or a special bank draft guarantee.	<u>1% of the Contract Price</u>

II. CLARIFICATION ON THE SUBMISSION OF SEALED QUOTATIONS

The Bids and Awards Committee, after seeking second opinion from the GPPB, wishes to confirm to the interested suppliers that the Submission of Filled-out Request for Quotation with technical and eligibility requirements scheduled on 28 June 2021 at 10:00 AM is **not the deadline but the time for the interested suppliers to submit the Sealed Quotations**. This also confirms the venue for the submission of sealed quotations at 56 Matimtiman St., Sikatuna Village, Quezon City.

The interested suppliers must submit their respective sealed quotations **before the Opening of Sealed Quotations** which is on 28 June 2021 at 11:00 AM. Quotations received during and after the conduct of the opening shall be marked as "Late".

III. INCLUSION OF TWO-STAGE INSPECTION BEFORE AND AFTER THE DELIVERY

In relation to the request of the BAC Vice-chairperson during the preliminary conference to include the Two-Stage Inspection during the delivery phase of the procurement. The two-stage inspection means that the procuring entity will inspect the vehicle before the delivery and will also inspection the vehicle after the delivery.

IV. CONCERN ON THE SAFEGUARD DUTIES

The stand of the Bids and Awards Committee on the Safeguard Duties imposed on imported vehicle is that all of the applicable taxes and fees must be included in the price quotation. Include in the breakdown of price quotation the part of the Safeguard Duties. There must be an undertaking that the supplier will return the paid Safeguard Duties in the event that the law is repealed.

The foregoing shall form part of the Notice for Negotiated Procurement. Any provision in the Bidding Documents inconsistent herewith is hereby amended, modified and superseded accordingly.
